As per terms and conditions of secondment of such employees, borrowing departments have to pay contribution towards Pension/CPS, Leave salary and DCRG to CSKHPKV, Palampur for the period of secondment.


It has been observed that ^{contributions} calculations on above account are not being sent to borrowing Department regularly with the result difficulties are being experienced by the University while settling retirement dues of such employees.

The competent authority has viewed the above lapse on the part of HODs/HOOs seriously and has ordered that details of contribution to be realized be sent by concerned HODs/HOOs to borrowing Department regularly in time failing which the HODs/HOOs concerned will be responsible for consequences.

In view of the above and to avoid complications at later stage, all the HODs/HOOs are requested to adhere to above instructions scrupulously. Copies of O.M. No. Fin.(C)B(15)-3/2014 dated 21.12.2017 and No. Fin-E-1-C(17)-13/2007 dated 06.02.2019 are enclosed herewith for ready reference and necessary action.


Subject:- Clarification regarding leave salary and pension contributions in respect of employees of PSUs who are on secondment to different Government Departments.

The under signed is directed to say that the matter regarding payment of leave salary and pension contribution in respect of employees who are on secondment from Public Sector Undertakings to different Government Department was under consideration of this department and after careful consideration it has been decided that in case of secondment from Public Sector Undertakings to Government departments the contribution towards leave salary and pension contribution is required to be borne by the Government departments as has been done in case of reverse secondment from Government department to PSUs vide this departments OM No. Fin (C) A (3)-11/89 dated 17/05/2004.

These orders shall be applicable with immediate effect and also be applicable in case of those Government servants who are already on secondment from Public Sector Undertakings to different Government departments.

The departments are requested to take necessary action accordingly to recover the leave salary and pension contribution in all such cases.



from surplus pool.**


Sir,
