





In exercise of the Powers conferred by sub-section(1) of Section 67 of the Motor Vehicle Act, 1988 (Act No. 59 of 1988) and in supersession of this department notification No. TPT-F(5)3/3003 dated 25-08-2011, the Governor of Himachal Pradesh is pleased to issue the following directions to the State Transport Authority, Himachal Pradesh, namely:

DIRECTIONS
