Grant of Interim Relief to the regular employees of the State Government of Himachal Pradesh.

Memorandums of even number dated: 2nd August, 2016, 4th August, 2017 & 9th February, 2018, on the subject cited above and to state that the Governor, Himachal Pradesh, is pleased to grant INTERIM RELIEF & 4% of the Basic Pay (Pay in the Pay Band + Grade Pay) with effect from 1st July, 2018, to be paid, in cash, with the salary of the month of August, 2018, on 1st September. 2018, to the regular employees of the State Government of Himachal Pradesh excluding officers of All India Services. The total 21 % interim relief (5%, 4%, 8% interim reliefs granted earlier and this 4% additional interim relief) shall not be treated as pay for the purposes of calculation and payment of any other kind of allowances including Dearness Allowance. The total amount of 21% interim relief will be absorbed in the future revision of pay scales to be allowed by the State Government

The arrears accrued on account of grant of this 4% interim relief from 01.07.2018 to 31.07.2018 in respect of all regular State Government employees will be paid in cash with the salary of the month of August, 2018, during September, 2018.
