Fixation of pay in the revised pay band in respect of Assistant Scientists/ equivalent who were appointed between 1-1-2006 to 31-8-2008.

13521 I am directed to refer to your letter No. QSD.5-160/14 CSKHPKV(Estt.)/-19592-95 dated 11th April,2017 on the subject cited above and to say that the matter was taken up with the Finance Department who have observed that those Scientists who acquired Ph.D degree during the time of recruitment i.e. w.e.f. 1.1.2006 to 31.8.2008 are entitled to grant of the benefit of advance increments as per ICAR guidelines issued on 27.2.1999. The pay scales have been revised w.e.f. 1.1.2006 and the rate of increment has been defined as 3 % of the pay in the Pay Band +Grade Pay, therefore, the revised rate of increment shall also be applicable as per provision contained in clause 7(a)(ii) of this Department notification dated 30 1 2009. The cases of those Scientists who acquired Ph.D time of their recruitment on or after 1.9.2008, are to be considered for grant of the benefit of non-compounded increments as per ICAR guidelines issued on 6.3.2009 and as per provision contained in clause 6 (i) of this Department notification dated 30.11.2009.

In view of above position, You are, therefore, requested to examine and decide the matter accordingly.
