OFFICE MEMORANDUM

Subject: - Grant of Dearness Relief to Himachal Pradesh Government Pensioners/Family Pensioners-Revised rate effective from 01-01-2018.

The undersigned is directed to refer to this department's O.M. No. Fin (Pen) B(10)-6/98-III dated 8<sup>th</sup> January, 2018 sanctioning one instalment of dearness relief with effect from 01-07-2017 and to say that the Governor, Himachal Pradesh is pleased to decide that dearness relief payable to the Himachal Pradesh Government Pensioners/Family Pensioners shall be enhanced from existing rate of 137 % to 140 % w.e.f. 01-01-2018. The Governor, Himachal Pradesh is further pleased to decide that dearness relief payable to the pensioners/family pensioners of All India Services of Himachal Pradesh Cadre who are drawing their revised pension on the basis of 7<sup>th</sup> Central Pay Commission report shall be enhanced from present rate of 5% to 7% w.e.f. 01-01-2018

2. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
