Grant of enhancement in the contractual emoluments payable to the employees working on contractual basis.

The emoluments payable to the employees working on contractual basis were enhanced by an amount equal to 50 percent of the grade pay of the post vide this department's Office Memorandum of even number dated 20<sup>th</sup> April, 2016. Now, the Governor, Himachal Pradesh is pleased to order that the emoluments payable to the employees working on contractual basis will be enhanced by an amount equal to 75 percent of the grade pay of the post against which they have been appointed on contract basis. Accordingly, now the contractual emoluments will be the sum of minimum of the pay band, applicable grade pay and 75% of Grade Pay applicable to the post against which they have been appointed on contract basis and are detting emoluments as per OM dated 3<sup>rd</sup> December, 2009.
