Government, as per O.M. No. Fin(C)-B(7)-1/2021 dated 09.02.2022 issued by the Additional Chief Secretary (Finance) to the Govt. of H.P. (copy enclosed).

The additional installment of Dearness Allowance of 3% shall be paid in cash with the salary of Feb. 2022 payable in March, 2022. The arrears for the period w.e.f. 01-07-2021 to 31.01 2022 shall be credited in the GPF account of the employees with the salary of Feb. 2022. The employees who governed under CPS the arrear on account of release of additional instalment will be paid in cash in the month of Feb 2022 payable in March 2022, depending upon the availability of funds.

**OFFICE MEMORANDUM**

**Subject: Grant of Dearness Allowance to the employees of the State Government w.e.f. 01.07.2021.**

In continuation of this Department's OM of even number dated the 3<sup>rd</sup> January, 2022, the Governor, Himachal Pradesh, is pleased to enhance Dearness Allowance @ 3% from the existing rate of 28% to 31% with effect from 01.07.2021 in respect of the employees of the State Government. These orders will be applicable to regular State Government employees covered by HP Civil Services (Revised Pay) Rules, 2022

2. This additional Dearness Allowance shall be paid in cash with the salary of February, 2022 payable in March, 2022 and the arrears accrued from 01.07.2021 to 31.01.2022 shall be credited in the GPF Accounts of the employees with the salary of February, 2022. The interest on this account shall accrue w.e.f. 1<sup>st</sup> March, 2022.

3. In case of the Government employees who have retired in between or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f. 01.07.2021 will be paid in cash with salary of February, 2022 payable in March, 2022.

4. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.


