

Subject:- Restoration of process of granting Four Tier Pay Structure (Pay Scales).

Sir/Madam,

I am directed to refer to the subject cited above and to say that 4-tier pay scales were granted to the eight specific services vide notification No. Fin(PR)B(7)-1/98-II dated: 01.09.1998 and detailed guidelines governing the terms and conditions for granting the 4-tier pay scales were issued vide letter No. Fin(PR)B(7)-1/98-II dated: 23<sup>rd</sup> June, 2000.

2. As a consequence of revision of pay scales w.e.f. 26.08.2009, it was decided/stipulated vide this Department's letter No. Fin(PR)-B(7)-1/98 dated: 31<sup>st</sup> August, 2009 that the cases of officers/officials who were eligible for placement in the next higher pay scale in the three/two tier pay scales under the pre-revised pay scales, may not be considered after 26<sup>th</sup> August, 2009, till further orders.

3. Now, after careful consideration of the matter, the Governor, Himachal Pradesh, is pleased to restore the process of granting
