**OFFICE MEMORANDUM**

**Subject:** Amendment of existing provisions and revision of entitlements of Travelling Allowance and Daily Allowance to the State Government employees.

The matter regarding revision of entitlement/rates of Travelling Allowance and Daily Allowance was receiving attention of the Government for some time. After careful consideration of the matter, the Governor, Himachal Pradesh, in partial modification of this Department OM No. Fin(C)-B(7)-14/98, dated the 8<sup>th</sup> December, 1998 and subsequent OM dated the 2<sup>nd</sup> June, 2006, is pleased to order amendments of existing provisions and revision of entitlements / rates of TA/DA in respect of State Government employees in the manner as under:-

1. **GRADATION:** The existing Grading pattern as prescribed in Para 2 (1) of Finance Department O.M. No. Fin-(C)-B(7)-14/98, dated the 8<sup>th</sup> December, 1998 is substituted as under:-
