Subject: Ex-gratia grant to the families of Government employees who die while in service.

The Governor, Himachal Pradesh, is pleased to order the revision of the entitlement for ex-gratia grant to the families of Government employees who die while in service to four times of the basic pay (Pay in the pay band+ Grade Pay) subject to a minimum of ₹35,000/- (Rupees Thirty five thousand only) and a maximum of ₹1,00,000/- (Rupees one lakh only).

2. The terms and conditions as already issued from time to time will remain unchanged.

3. These orders will also be applicable to the officers of All India Services borne on the respective cadres of the State Government.

4. These orders will be applicable from 01-04-2012 and the cases relating to the period prior to 01-04-2012 shall be regulated in accordance with the then existing orders and the cases already decided under those existing instructions will not be reopened.
