

NOTIFICATION

The Academic Council vide item No.7 of its 168th meeting held on 30.03.2017 has amended the Academic Regulations 7.21.1(ii) and the proviso after Academic Regulations 7.21.3 as under:

Accreditation of Staff Member for Postgraduate Teaching/ Research	7.21.1(ii)	A teacher possessing Ph.D. degree in the allied subjects shall be considered for accreditation to guide research at Master's level provided that he/she has a minimum experience of teaching/ research/ extension education in the concerned discipline for a period of 5 years in case of Ph.D. degree holder and 8 years in case of M.Sc. degree holder. He/she should have at least 3 research papers published in journals of repute.	A teacher possessing Ph.D. degree in the allied subjects shall be considered for accreditation to guide research at Master's level provided that he/she has a minimum experience of teaching/ research/ extension education in the concerned discipline for a period of 3 years in case of Ph.D. degree holder and 5 years in case of Master's degree holder. He/she should have at least 3 research papers published in journals of repute.
	Proviso after Academic Regulations 7.21.3	Provided that the Professor/equivalents shall automatically be treated as accredited to guide PG students relaxing all above conditions.	i) Provided that the Professor/equivalents shall automatically be treated as accredited to guide PG students relaxing all above conditions in major and allied disciplines. ii) Provided that once a teacher in allied discipline is accredited in multidisciplinary department, he/she will cease to guide any student of his/her parent department till he/she continues in multidisciplinary department.

As a sequel to above, Notification No. QSD.11-10/CSKHPKV(Acad)/-16336-430 dated 12.03.2015 be deemed to have been amended to the above extent.


