

Academic Regulation governing- 'Minimum Class Attendance'			
	Existing		Amended
4.1.1	Each student shall be required to attend at least 75% of lectures scheduled and practicals conducted in each course. The attendance shall be taken for theory and practical classes separately. Each Instructor shall, however, periodically keep the students informed about the shortage of their attendance, if any.	4.1.1	Each student shall be required to attend at least 75% each of lectures scheduled, parades/ periods (NCC/NSS) and practicals conducted in each course. The attendance shall be taken for theory and practical classes separately by the Course Instructor(s) in the Acad Form No.7-a . Each Instructor shall, however, periodically keep the students informed about the shortage of their attendance and shall notify the attendance of the students in the 10 th week of the semester under intimation to the Head of Department/ Students' Welfare Officer & Dean concerned. The Dean shall inform the shortage of attendance of the student, if any, to his/her parent/guardian and advisor (Major Advisor in case of PG student).
