NOTIFICATION

Captain, Ramesh Chand). The copy of the approved rates enclosed). These rates shall be applicable from April 1, 2011 to March 31, 2012. The minimum wages are, however, subject revision by the state Government and further adoption by the University. The agreement deed has been signed between CSK HPKV (First party and M/S Sun Security Services (Branch Office), Ward No. 5, Vinay gali, Nurpur, District Kangra, HP (Branch Manager: Hony. Captain, Ramesh Chand, Contact No. 08894845994). Copy of the agreement deed has been uploaded on the University website: www.hillagric.ernet.in. The outsource services shall strictly be as per terms and conditions agreed upon between the first party (CSKHPKV) and the agency (Second Party) (Copy of terms and conditions is available on: www.hillagric.ernet.in.)

The Heads of the Departments/Associate Directors/Station Incharges/Programme coordinators/Controlling Officer(s) of any other unit are requested to outsource manpower for the period April 1, 2011 to March 31, 2012 for smooth conduct of research and other activities after getting one time sanction from the competent authority.

Henceforth, it is enjoined upon all concerned that:

1. The scheme/projectwise monthly requirement for required services w.e.f. April 1, 2011 to March 31, 2012 may be given to the agency outsourcing the services.
2. It shall be ensured that the unskilled/skilled services are outsourced only to: M/S Sun Security Services (Branch Office), Ward No. 5, Vinay gali, Nurpur, District Kangra, HP (Branch Manager: Hony. Captain, Ramesh Chand).
3. The Research stations located in the tribal areas viz.: Highland Agricultural Research Station, Kukumseri, Highland Agricultural Research Substation Lari, Highland Agricultural Research substation, Leo, MAREC, Sangla have been kept out of the contract deed. The station in-charges of these stations may outsource the work by way of locally inviting quotations.
4. The present notification for skilled manpower shall be applicable to all the skilled categories contained in notification No. Fin. (PR)B(7)-33/2010 dated 7/9/2010 and further adopted by the University vide notification No. QSD.Bud.5-106/07/ CSKHPKV /- 2250-2368 dated 7.1.2011 (Copy of the notification is uploaded on the University website: www.hillagric.ernet.in)
