NOTIFICATION

Consequent upon the terms and conditions as agreed upon in the original tender document, agreement deed with the approved outsource services providing agency, adoption of enhanced rate of minimum wages by the University vide notification No. QSD.Bud.5-106/14/CSKHPKV/-35067-161 dated 20.07.2018 as prescribed by the Govt. of H.P. vide notification No. FIN-(PR)B(7)-33/2010 dated 16.04.2018. the Hon'ble Vice-Chancellor, CSKHPKV, Palampur has been pleased to make the payment of enhanced rate of minimum wages to the approved service providing agency for outsource services as such w.e.f. 01.04.2018 onwards.

Accordingly, the revised gross rates in respect of each category of outsource services have been worked out and enclosed as Annexure-I & II applicable for tribal and non-tribal areas respectively.

It is, therefore, enjoined upon all concerned that :-

1. Sanction cases as per revised rates from 01.04.2018 to 30.09.2018 may kindly be got revised immediately through the respective controlling officers of the projects/schemes concerned.
2. Since the contract period of the existing approved service providing agency M/s Sampark Services is going to expire on 30.09.2018, the amount of arrears be paid immediately i.e. on or before 31.08.2018. Delay in making the payment of arrears beyond the given date shall be viewed seriously.
