NOTIFICATION

On the recommendations of the committee constituted for opening/scrutinizing the tenders for outsource services, the Hon'ble Vice-Chancellor, CSKHPKV, Palampur has been pleased to award service contract for providing outsource services to M/s Universal Training & Research Institute, Luxmi Bhawan North Oak, Sanjauli, Shimla, Branch Office House No. 97, Him Huda Colony, Holta Palampur on the basis of lowest quoted rate of services charges i.e. @ 2.00% of min. wages. The contract shall be valid from 01.04.2020 to 31.03.2021.

It is, therefore enjoined upon all concerned that:-

1. The wages rates of various categories of services enclosed as ANNEXURE may be followed.
2. Sanction cases for required outsource manpower may be submitted to the controlling officers of the respective schemes well before the manpower is outsourced. Obtaining one time sanction for the period under contract be preferred.
3. It may be ensured that the payment of wages as prescribed in respect of outsourced manpower is made through the service providing agency by the 7th of each following month in pursuance to the provision contained in the Payment of Wages Act, 1936 and agreement with the agency concerned.
4. It may also be noted that except peculiar circumstances, no ex-post facto sanction cases for outsource manpower shall be entertained.
5. The TDS on each wages bill of the agency shall continue to be deducted @2% of the gross amount.

9. Consolidated monthly report of the work done by outsourced manpower shall have to be countersigned by the HoD concerned.
10. The following certificate by the PI/DDO/HoD concerned shall be essential at the time of processing the wages bills for payment:-


