In pursuance of the decision of the Finance Committee taken vide item No.115(10) of its 115th meeting held on 9.2.2018 duly approved by the Board of Management vide item No.3.4 of its 113th meeting held on 9.2.2018 and on the recommendations of the Committee constituted vide office order No.QSD.5-103/2015/(CT)CSK HPKV (Estt.)/-13216-21 dated 12.3.2018, the Vice-Chancellor, CSKHPKV, Palampur has been pleased to absorb the services of following Drivers with immediate effect who were appointed on co-terminus basis in the running scales /pay band under Krishi Vigyan Kendras/All India Coordinated Research Projects/other Govt. of India's Projects and have completed 10 or more years of service on co-terminus basis, against the vacant posts of Drivers as shown below in the pay band of Rs.5910+20200+2000 Grade Pay plus other allowances as admissible from time to time:-

The absorption is further subject to the following terms & conditions:-

1. That they will be on probation for a period of two years from the date of issuance of absorption orders in the first instance.
2. That their pay will be protected / fixed as per rules of the Vishvavidyalaya.
3. That they will have to produce a medical fitness certificate from the Medical Officer, CSKHPKV, Palampur or H.P. State Govt., if not produced earlier.
4. That they will continue to work as such under the concerned project/KVK and their salary will also be continued to be charged from concerned project/KVK till the funding agency provides funds under salary head. However, they will be shifted to the State Schemes in the event of termination/closure of project/KVK or withdrawal of post(s) or non-providing of funds by the concerned funding agency, as the case may be.
5. That they will continue to subscribe towards the Contributory Pension Scheme (CPS)/ New Pension Scheme (NPS), to which they are already subscribing.
6. That they will be liable to be posted anywhere within the territorial jurisdiction of the Vishvavidyalaya.
7. That they will continue to be a member of Group Saving Linked Insurance Scheme of the Life Insurance Corporation of India as introduced by this Vishvavidyalaya.
8. That they will have to submit a return of assets and liabilities on acceptance of their absorption.
9. That they will be called upon to do work as per their job requirement or any other work as may be assigned to them by the Controlling Officer from time to time.
10. That they will not engage themselves in any other work or carry out business except with the permission of the Competent Authority.
11. That their absorption is subject to the verification of their character and antecedents, if not verified earlier.
12. That the past service rendered by them as Drivers on co-terminus basis will be counted for the purpose of grant of benefits under Assured Career Progression Scheme(ACPS) as per rules without consequential monetary benefits and no arrear on this account will be paid to them by the University. However, financial benefit, if any, will be given with prospective effect.
13. That their seniority shall be determined with immediate effect i.e. from the date of issuance of absorption orders as per rules and they will be placed at the bottom after all direct recruits and promotees in the seniority list as on the date of absorption. However, the seniority will be determined in accordance with the merit drawn by the Selection Committee for the post at the time of initial appointment on co-terminus basis.
14. That their service conditions will be governed by the Himachal Pradesh Universities of Agriculture, Horticulture and Forestry Act, 1986, Statutes, Rules/Regulations framed thereunder from time to time.

Since the above terms & conditions of absorption have already been accepted by them vide their undertakings dated 27.6.2018/29.6.2018/30.6.2018, they may report for duty to the concerned Programme Coordinator/Controlling Officer within a period of 15 days of the issue of this order failing which the orders will be treated as cancelled.
