
CIRCULAR

The Government of Himachal Pradesh vide letter No.Per(SA-R&I-II)7(G)6-1/2008 dated 11.06.2018 (Copy enclosed) has completely banned the use of plastic bottles of any kind, be it for the purpose of drinking water or otherwise, in all the Government offices, Boards, Corporations, Universities etc. due to its adverse effect on health and environment.

The competent authority in the University has approved that the ibid instructions/guidelines issued by the Govt. are strictly implemented in the University. It is also brought to the notice of all the concerned that no drinking water contained in the plastic bottles, will be used/served in meetings, conferences, seminars henceforth.

Therefore, it is hereby enjoined upon all the functionaries of the University to bring the contents of H.P. Government instructions under reference to the knowledge of all the employees/students working/studying under them for strict compliance. Any violations would be viewed seriously and strict action would be taken against the defaulters.


