Sir,

Regarding tenders floated by the State Transport Agencies for procurement of buses/hiring or leasing services for buses through GeM.

Kindly refer to D.O. letter No. 36/ACEC-Gem/2018 dated 17.12.2018 of the Commerce Secretary, Government of India, New Delhi, addressed to the Chief Secretary, Government of Himachal Pradesh on the subject cited above (Photocopy enclosed).

Vide above D.O. letter, it has been informed that the tenders are being floated by the State Transport Agencies for procurement of buses/hiring or leasing services for buses, notwithstanding the fact that automobiles are available on Gem at highly discounted rates ranging from 12% to 20% over market rates, leading to huge saving to state exchequer. This discount is not available when vehicles are procured outside GeM either through bid or at special Govt. prices. The GeM has all the major automobile companies directly listing all models of vehicles including buses and recently they have enabled bus hiring/leasing services also.

It is submitted that the Government of H..P. has implemented GeM Portal facilities for procurement of items by all the Government offices of H.P. for which necessary directions have already been issued by the Principal Secretary(Industries) to the Government of H.P. vide letter of even No. dated 20.08.2018 & subsequently by Controller of Stores, H.P. vide letter of even No. dated 04.09.2018 for adhering to the provisions contained in the Notification No. Fin(c) A(3) 5/2004 dated 19.07.2017 issued by the Finance Department to the Government of H.P. and purchasing the stores/items through GeM and ensuring that the stores are purchased in a transparent manner and on competitive rates

You are, therefore, requested to give necessary directions to the Managing Director, Himachal Pradesh Road, Transport Corporation, Shimla, H.P. for procuring the above vehicles only through GeM Portal which would lead to significant savings.
