



R/sir,

Respectfully, it is submitted that the instructions issued by the Govt. of India in respect of Minority Certificate not mandatory for getting the benefits of welfare schemes are not being implemented as yet by the head of the departments in the state.

You are, therefore, requested to kindly issue suitable directions/instructions to all the head of the departments in the state including all Deputy Commissioners, Directors, Higher Education, Elementary Education, SDMs and Tehsildars etc. to follow the orders issued by the Govt. of India regarding not mandatory of produce Minority certificates for getting benefits of welfare schemes.

In view of the letter No. DO No. Misc/DL/3/2005 dt. 26-07-2018 from Sh. Rama Krishna Rao, Secretary of National Commission for Minorities Govt. of India, addressed to Chief Secretaries of all states Govt./UT and Principal Secretaries:-

1. The Minority Certificate is not mandatory for getting the benefits of welfare schemes implemented by the said ministry.
2. A self certification by the candidate should be accepted.

It is also added here that the instructions circulated by the Ministry of Minority Affairs, Govt. of India under the signature of Sh. Pradeep Kumar, Under Secretary to the Govt. of India, vide letter No F.No.2/37(2)/2014-SSS dt. 22-08-2014 addressed to the Principal Secretary/Secretary all State Govt./U.T. Administration:-

- 1. Removal of requirement of affidavit for Minority Community Certificate and Income Certificate for availing the scholarships **such as Pre-Metric, Post Metri and Merit-cum-Means.**

As per instructions and guidelines:-

- (a) For Minority certificate:-Self Certificate of the student is sufficient.

But in the state the education department and others did not follow and obey the instructions and the students are being still compelled for production of minority certificate for the purpose of scholarships.

The Worthy Chief Secretary, Govt. of Himachal Pradesh is requested to kindly issue the suitable instructions/guidelines to all the head of the departments implements the orders circulated by Govt. of India as cited above.

This Commission has been receiving several complaints regarding issue of Minority certificate by the district authorities. In this regard it is informed that Minority Certificate is not mandatory for getting the benefits of the welfare schemes being implemented by this Ministry. A self certification of the candidate should be accepted. In this regard, Ministry of Minority Affairs letter dated 18.05.2015 is enclosed.

2. You are requested to issue necessary instructions to all collectors at districts level to follow the above circular, so that Minority Communities do not face any problem while getting minority certificate.

3. I shall be grateful, if you could kindly look into the matter and take appropriate action.

Subject: Issuance of Minority Certificates.- regarding

Sir,

I am directed to state that the Government of India established a new Ministry the Ministry of Minority Affairs on 29<sup>th</sup> January, 2006 to ensure a more focused approach towards the issues relating to minorities and to facilitate the formulation of overall policy and planning, coordination, evaluation and review of the regulatory framework and development programmes for the benefit of the minority communities. In addition to the five communities already notified as minorities viz. Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis), the Ministry has issued a Gazette Notification on 27<sup>th</sup> January, 2014 (copy enclosed) regarding inclusion of Jain community.

2. This Ministry is receiving several letters, representations, RTIs and grievances from the Minority Communities especially from Jain Community stating that they are unable to avail the benefits extended to the minority communities, in the absence of minority certificates issued by the concerned Revenue or other authorities of the State Governments. In this context it is informed that Minority Certificate is not mandatory for getting the benefits of the welfare schemes being implemented by this Ministry. A self certification of the candidate is accepted by this Ministry. In this regard this Ministry has already issued instructions vide letter No.3/37(2)/2014-SS dated 22-08-2014 (copy enclosed)

3. However, in case Minority Certificate is required for any other purpose by the State Government you are requested to kindly direct the concerned authorities under your State Government to issue the Minority certificates expeditiously, as and when any candidate applies for the same after following your own procedure.

**Subject: Removal of requirement of Affidavits for Minority Community Certification and Income Certification for availing Scholarships- regarding**

Sir/Madam,

It has been decided with the approval of Competent Authority in the Ministry that requirement of submission of Affidavit towards (i) Community Certificate and (ii) Income certificate under Pre-matric, Post-matric, and Merit-cum-Means based Scholarship Scheme for students belonging to the notified minority communities have been done away with immediate effect. However, this may not apply for application already received by the State Government/UT Administration under these Schemes.

2. For Community Certificate, self-certification of the student is sufficient while for income certification, only the certificate issued by the Competent Authority of the State/UT concerned will be accepted.

3. It is requested that necessary directions may be issued by the State Government/UT Administration in this regard.

4. Documentation under the Scholarship Schemes for students belonging to the minority community also stands amended.
