
Sir,

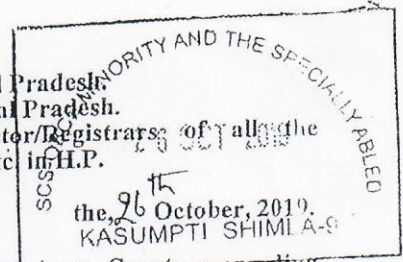

Implementation of RPwD Act, 2016
Sir/Madam



On the above cited subject, it is to inform you that in compliance to the reply submitted by you w.r.t. this Directorate letter of even no. dated- 22-06-2019, a compliance report was submitted by the State Govt. in the Hon'ble Apex Court. The case was heard on 19-08-2019 and again on 23-09-2019. The Hon'ble Apex Court is not satisfied with the progress made by the State Govt. regarding implementation of various provisions enshrined under various sections of the Rights of Persons with Disabilities Act, 2016 and has ordered the State Governments to file a fresh reply/ full compliance report having full compliance of each and every section of the RPwD Act, 2016, within a period of EIGHT WEEKS from the date of order. The copy of the Hon'ble Apex Court order is enclosed alongwith this letter. The case is now, listed/heard in the month of December, 2019.

In this context, it is submitted that for the proper implementation of RPwD Act, 2016, this Directorate time and again, requested all the Departments to take necessary action w.r.t. the various sections of the RPwD Act, 2016, pertaining to their Department. Further, to sensitize the Govt. officers/officials about the various provisions of the Act, a one day meeting-cum-workshop was also organized by this Directorate on dated:- 15-09-2019, at HIPA, wherein, the section wise responsibilities of the Departments was conveyed to all the participants. The same was again shared with all the Departments vide this Directorate letter of even no. dated- 22-06-2019. Further, a review meeting was also held on dated- 01-07-2019 under the Chairmanship of Director ESOMSA, wherein, all the Departments were again requested to take immediate necessary steps for the implementation of the various section of RPwD Act, 2016 pertaining to their Department.

In view of the above, you are requested to look into the matter personally and take immediate necessary actions w.r.t. the implementation of various section of RPwD Act, 2016, pertaining to your Department and submit the fresh status/compliance report to this Directorate within 15 days positively. As the compliance report is to be filed in the Hon'ble Apex Court by the Worthy Chief Secretary Govt. of Himachal Pradesh, a review

meeting may also be convened by the worthy Chief Secretary Govt. of Himachal Pradesh, shortly.
