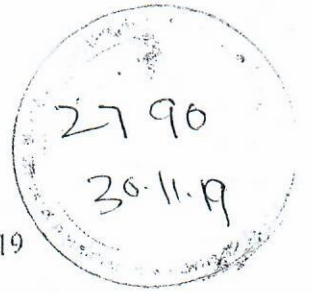

**NOTIFICATION**

The Governor, Himachal Pradesh is pleased to declare 29<sup>th</sup> November, 2019 as public holiday (in case poll is held) in Gram Panchayat Chhatroli Development Block Nurpur, District Kangra where bye- election is scheduled to be held to fill up the vacant seat of Pradhan. All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops will remain closed on the said date in the area of above Gram Panchayat. This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in said Gram Panchayat, on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.
