It is for the information of all concerned that keeping in view of the present threat of COVID-19, the **End Term /Annual Examinations of left out classes of CSKHPKV, Palampur for the Academic Year 2019-20 will be held online from 05.10.2020 to 25.10.2020 as per following guidelines for the conduct of examination and evaluation:**

- i. The course instructors shall prepare the question paper in such a way that the question paper covers the entire syllabus of theory as well as practical (if applicable). The question paper should test the analytical and thinking ability of the students.
- ii. The question paper shall be sent to the students 15 minutes before the start of examination on their designated email ID/Whats App group.
- iii. The students will attempt the question papers on the white sheets to be arranged by them and will answer the questions in their own handwriting.
- iv. The duration of the examination will be two hours.
- v. The students shall compulsorily sign on every page of the answersheet and reflect his/her name, Admission No. and paging before submitting the answer sheets.
- vi. The snapshots of the signed and attempted answer sheets shall be sent on the designated email ID/ Whats App within 15 minutes after the duration of the examination is over. The PDF files will be preferred.
- vii. Each registered student will submit a written consent two days before to appear in the examination to their concerned Class Incharge(s)/Tutor through Advisor/Head of Department.
- viii. In the rare event of a student unable to appear in the online examination, such a student will submit a written application alongwith valid reason(s) through email/Whats App number in atleast 24 hours to the Dean Office through Advisor/Head of Department.
- ix. All such students, who are permitted by the concerned Dean for not appearing in the online examination shall have to appear in the offline examination compulsory in the next semester. However, in such a case the students will be evaluated through the external/internal examination process as per existing Academic Regulations by the University.
- x. Concerned course Instructor(s) will evaluate the answer sheets according to his/her earliest convenience, but should maintain the electronic or printed record of the marks.
- xi. The Practical examinations will be held as per the date sheet notified by the concerned Dean. Assignments and Whats App viva-voce may be accomplished in the online practical examinations.
- xii. All such students who fail to attempt and submit the answersheet because of any reason within the prescribed time limit would only be considered for offline examination later on.


