WHEREAS, Dr. Arvind Kumar, Principal Extension Specialist (Extension Education), KVK, Una was granted two years Extra Ordinary Leave from the date of relieving to take up the assignment as Principal Scientist (Agricultural Extension) at ICAR-Agricultural Technology and Application Research Institute (ATARI), Ludhiana, vide this office order No.QSD.6-619/98-CSKHPKV (Estt.)/-36310-18 dated 20.07.2016;

AND WHEREAS, the said Dr. Arvind Kumar was relieved by the Programme Coordinator, KVK, Una on 21.07.2016 (AN) vide office order No.QSD/CSKHPKV/KVKU/1-2/2016/-248-257 dated 21.07.2016.

AND WHEREAS, the period of two year Extra Ordinary Leave expired on 21.07.2018 (AN) and the said Dr. Arvind Kumar was to join back his duties in this Vishvavidyalaya after expiry of Extra Ordinary Leave on 22.07.2018 (FN) but he did not resume duties after the expiry of Extra Ordinary Leave and sought extension in Extra Ordinary Leave beyond two years;

AND WHEREAS, the extension for Extra Ordinary Leave for another period of three months w.e.f.22.07.2018 to 21.10.2018 was granted to the said Dr. Arvind Kumar to continue the above assignment vide this office order No.QSD.6-619/98-CSKHPKV(Estt.)/-46512-21 dated 19.09.2018;


AND WHEREAS, the said Dr. Arvind Kumar did not resume his duties after expiry of Extra Ordinary leave on 22.10.2018 (FN) and sought extension in Extra Ordinary Leave for one year i.e. up to 21.07.2019;

AND WHEREAS, the request of the said Dr. Arvind Kumar for extension in Extra Ordinary Leave beyond 21.10.2018 was not acceded to by the competent authority keeping in view the shortage of teachers in the discipline of Extension Education and accordingly he was intimated vide this office letter No.QSD.6-619/98-CSKHPKV(Estt.)/-52767-70 dated 23.10.2018 either to join back immediately or resign from the service of this University so that the post could be filled up in this discipline;

AND WHEREAS, instead of resuming his duties in CSKHPKV, Palampur, the said Dr. Arvind Kumar vide his letter 21.11.2018 informed that he wants to absorb in the ICAR services as Principal Scientist (Agricultural Extension) and has requested to consider his said request as his technical resignation from the date of his relieving from CSKHPKV-KVK, Una i.e. w.e.f.21.07.2016 (AN).

AND WHEREAS, in view of the above, the Vice-Chancellor, CSKHPKV, Palampur has ordered termination of lien of the said Dr. Arvind Kumar from the post of Principal Extension Specialist (Extension Education) from this Vishvavidyalaya w.e.f.21.7.2016 (AN).

NOW THEREFORE, the lien of said Dr. Arvind Kumar is hereby terminated from the post of Principal Extension Specialist (Extension Education) from this Vishvavidyalaya w.e.f.21.7.2016 (AN).
