
OFFICE ORDER

Therefore, the teaching and non-teaching employees as notified vide this office order No.QSD.10-28/2020-CSKHPKV (Estt.-II)/- 15585-684 dated 13.04.2020 **shall stand relieved from the University service on 30.04.2020 (A.N.) on their retirement after attaining the age of superannuation.**






