Subject: Regarding re-fixation of pay.


Sir,

I am directed to refer to this office order No.QSD.5-166/19-CSKHPKV(Estt.)/-59718-99 dated 27.12.2019 vide which this office order No.QSD.5-166/14/CSKHPKV(Estt.)/-52073-145 dated 14.9.2017 was withdrawn and office order No.QSD.5-116/10/CSKHPKV(Estt.)/-79105-94 DATED 18.8.2010 was restored in pursuance of the judgement delivered by the Hon'ble H.P. High Court on 20.8.2019 in LPA No.458/2011 titled as CSKHPKV & Ors. Vs. Shyam Verma & Others.

In this connection, it is intimated that now the Hon'ble H.P. High Court passed an order on 21.8.2020 in review petition No.31/2020 titled as Punita Suri & Ors. vs CSKHPKV, Palampur & Ors. that the judgment dated 20.08.2019 is a nullity and consequently, the review petition is allowed and the LPA No.458 of 2011 is ordered to be restored to its original number. Accordingly, the Vice-Chancellor, CSKHPKV, Palampur has allowed to stop the process for re-fixation of pay in respect of all the respondents as mentioned in above office order dated 27.12.2019 till decision of the Hon'ble H.P. High Court on the LPA.No.458/2011.

In view of the above, it is requested to take further necessary action in the matter accordingly.
