

OFFICE ORDER

Consequent upon issuance of instructions by the Secretary (AR) to the Government of Himachal Pradesh vide letter No. Per(AR)B(15)-1/2012 dated 17.12.2019 that fee received under RTI, Act, 2005 is to be deposited in Government treasury, the Vice-Chancellor, CSK HPKV, Palampur has been pleased to allow to deposit the receipts from RTI in Government Treasury under specific head of account allocated by FD i.e. "0070-60-118-01 in future instead of any other account.


