



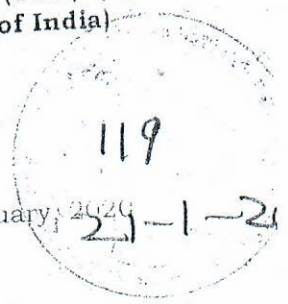

NOTIFICATION

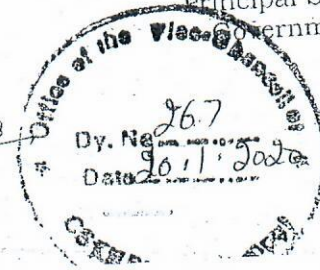
In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission is pleased to make the following amendments under Annexure -II, relating to Initial selection, Training and Examination Rules for appointment to the post of Section Officer appended to the Himachal Pradesh Finance and Accounts Service Rules, 2018 notified vide this Department's notification No. 3-1/75-Fin(T&A)-IV dated 19.04.2018, in the Department of Treasuries, Accounts & Lotteries, Himachal Pradesh, namely :

1.	Short title and commencement	1. These rules may be called the Himachal Pradesh Finance and Accounts Service (First Amendment) Rules, 2019. 2. These Rules shall come into force from the date of publication in Rajpatra, Himachal Pradesh.
2.	Amendment under Rule 8(5) to Annexure -II of Himachal Pradesh Finance and Accounts Service Rules, 2018	In order to pass the examination, a candidate must obtain 50% marks in each paper. Where there are two parts in a paper, marks obtained in both the parts shall be counted together: Provided that if a candidate who passes the paper(s) with minimum 50% marks but fails to pass one or more paper(s) of Himachal Pradesh Finance and Accounts Service Part-I and Part-II examinations, shall not be required to appear again in passed paper(s).
3.	Amendment under Rule 8(6) to Annexure -II of Himachal Pradesh Finance and Accounts Service Rules, 2018	A candidate who fails to qualify the paper(s) of the Himachal Pradesh Finance and Accounts Service Part-I examination with the prescribed standard shall be eligible to be admitted in Himachal Pradesh Finance and Accounts Service Part-II training with the successful candidates having qualified the Himachal Pradesh Finance and Accounts Service Part-I Examination with the prescribed standard: Provided that the result of Himachal Pradesh Finance and Accounts Service Part-II examination in respect of such failed candidate shall not be declared until he/she qualifies the Himachal Pradesh Finance and Accounts Service Part-I examination with the prescribed standard: Provided further that in case a candidate fails to qualify all papers of the Himachal Pradesh Finance and Accounts Service Part-I & Part-II examinations with the prescribed standard in three admissible chances then his/her result for these examinations shall stand cancelled automatically.
