It is for the information of all concerned that the Academic Council vide Item No.12 of its 187th meeting held on 23.01.2021 has decided to **open the Colleges of this University for the students to attend the classes as under:**

- 1. All the remaining classes of Undergraduate Programmes (except 1st year classes) w.e.f. 01.02.2021;**
- 2. 1st year classes of all Undergraduate programmes w.e.f. 08.02.2021;**
- 3. All the classes of Postgraduate programmes w.e.f. 01.02.2021.**

The above opening of Colleges of the University is subject to the following:

- 1) The SOP on preventive measures to contain spread of COVID-19 in skill or entrepreneurship training institutions, higher educational institutions conducting doctoral courses and post graduate studies in technical & professional programs requiring laboratory/experimental work issued by the Ministry of Health & Family Welfare, Government of India dated 08.09.2020 and revised SOP on preventive measures to be followed while conducting examinations to contain spread of COVID-19 issued by the Ministry of Health & Family Welfare, Government of India dated 10.09.2020 will be followed strictly.
- 2) In case the number of students is more than the capacity of classrooms following physical distancing norms, then the Dean will make appropriate arrangement to follow the physical distance.
- 3) The students shall have to submit the negative test report of COVID 19 from ICMR COVID - 19 test facility to the concerned Dean/ the Students' Welfare Officer of the University at the time of their arrival in the University and the said test report of COVID 19 should not be more than 3 days old.
- 4) The Dean, Students' Welfare Officer, Head of Departments, Advisors and Wardens will get the SOPs followed strictly and visit the hostels frequently.
