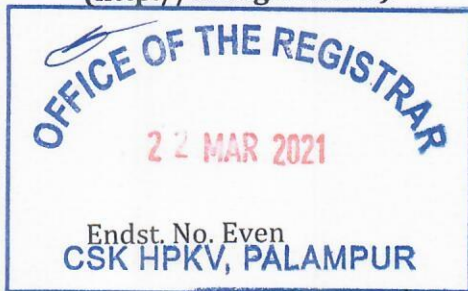
NOTICE
