



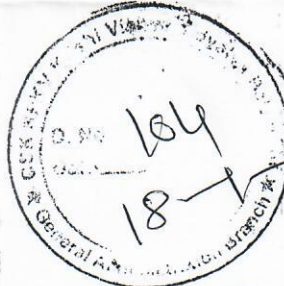

**ORDER**

In continuation of State Executive Committee's Orders No. Rev (DMC) (C)-2020-COVID-19 dated 5<sup>th</sup> January, 2021, and in exercise of the powers conferred under the Section 24 (e) of the DM Act, 2005; the undersigned in capacity of the Chairman, State Executive Committee (SEC) after a comprehensive review of the current covid-19 situation hereby orders the following amendments in the existing instructions/guidelines and directs all the Departments and Organizations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State to ensure strict implementation of the directions:-

**Following directions stand amended:**

Henceforth all social/religious/sports/entertainment/educational/cultural/religious gatherings, are allowed with a maximum gathering of 50% of the capacity, with a ceiling of 200 persons in closed spaces; and 50% of the size of the open grounds/spaces subject to compliance of all instructions, SOPs/advisories regarding social distancing and wearing of face covers etc.
