OFFICE ORDER


In pursuance of instructions issued by the Principal Secretary (Revenue) to the Govt. of Himachal Pradesh, Revenue Department - Disaster Management, Cell, Shimla vide order No. Rev(DMC)(C) 20-2/2021-COVID-19-III dated 15.05.2021 (Copy enclosed) regarding extension of 'Corona Curfew' period in the State, the Vice-Chancellor, CSK HPKV, Palampur has been pleased to order that the University shall remain closed during the **'Corona Curfew' period upto 6:00 AM of 26th May, 2021.**

All other provisions of the instructions issued vide this office orders/circulars dated 26.03.2021, 03.04.2021, 12.04.2021, 15.04.2021, 20.04.2021 and 01.05.2021, 06.05.2021, 09.05.2021 and 10.05.2021 shall continue to be operative during the above 'Corona Curfew' period.

All should note that SoP for social distancing and COVID safety protocols issued by the University, District administration, National Health mission, HP and Govt. of H.P. from time to time be adhered to in letter and spirit.

The Associate Directors/ Scientist Incharges/Programme Coordinators, RRS/ RSSs/KVKs, will also adhere to the instructions issued in this behalf by the District Administration of concerned district.

All the Statutory Officers, Heads of the Departments/Units/Offices, Associate Directors/ Scientists Incharge/Programme Coordinators are requested to bring it to the notice of all employees (teaching and non-teaching) and students working/studying under their control including project staff and outsourced agency/service provider and ensure that no deviation/departure from the same is made by any functionary/ individual.



ORDER

In continuation of SEC's Orders dated 05.05.2021, 06.05.2021, 08.05.2021 & 13.05.2021, keeping in view the surge of COVID-19 cases and considering the current situation of COVID-19 pandemic and fatalities across the state, the undersigned, in the capacity of the Chairman (SEC), exercising the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act, 2005 hereby directs that restrictions imposed vide aforementioned order of 05.05.2021 shall stand further extended till 6 AM of 26th May 2021.

1. The "Corona Curfew" shall stand extended from 6 AM of 17th May 2021 to 6 AM of 26th May 2021
2. Restrictions placed on attendance of maximum 20 persons in marriages should be strictly followed. It is further directed that for the purpose of marriage no marriage palace, community hall or tented accommodation shall be utilized. No outside catering and DJ/Band shall be utilized and there shall be no procession of the *Barat*. All marriages shall be performed inside homes. The organizers must ensure that social distancing is maintained during the function.
3. Hardware shops shall be allowed to open on Tuesdays & Friday for three hours as per schedule fixed by the District Magistrates for shops of daily needs and essentials goods during the period of the curfew in the respective districts.
4. The Department of Excise & Taxation shall be included in the list of offices which shall remain open as per X(i) of Order dated 05.05.2021.

All other exemptions and restrictions shall continue to remain as per guidelines issued vide order dated 05.05.2021, 06.05.2021, 08.05.2021 & 13.05.2021.

This Order shall remain in force, in all parts of the State for the period as aforementioned.


