
On the recommendations of the Employees' Retirement Farewell Fund Committee, the Vice-Chancellor has been pleased to approve the changes made in the " Employees Retirement Farewell Fund" Rules as under with immediate effect:-

OR Due to COVID-19 pandemic, Light refreshment Rs. 500/- (Rupees Five Hundred only) to the concerned department for celebrating the retirement function.

Further, it has been decided that the purchase of gift items to be given to the retirees on their retirement function be continued till 31<sup>st</sup> March, 2022 from M/S Dinesh Agencies, Palampur on the same rates at par with the M/S Mahadev Enterprises (whose rates were approved) and the process of purchase of gift items (approval of rates) will be taken up after 1<sup>st</sup> April 2022 afresh.

It has also been decided that the outstanding bill, if any, of both the firms viz. M/S Mahadev Enterprise and M/S Dinesh Agencies, Palampur be cleared on priority basis.
