
OFFICE ORDER

The Nodal Officer shall apprise the Vice-Chancellor and the Registrar regularly twice in a day with the data and report based on the data submitted by the members with correction at his level, if any. There will be discussion on the status of submitted reports/data in the forenoon and afternoon daily by the Vice-Chancellor, Registrar and Nodal Officer.


