It has been observed that despite issuing of instructions vide office order No.QSD.8-73/2015/CSK HPKV(GA)/61917-62011 dated 09.11.2015 and office order even No.66658-757 dated 09.12.2015, some of the students and employees of the University are still not observing the traffic rules as laid down in Moter Vehicle Act in letter and spirit.

In view of the above, instructions issued vide office order dated 09.11.2015 and 09.12.2015 as safety measure to the students as well as employees of the University are hereby re-iterated for strict compliance. All the Deans of the constituent Colleges, Students' Welfare Officer and other controlling officers of CSK HPKV, Palampur are, therefore, requested to ask the employees and students working /studying under their control to restrict the speed limit of the vehicles around 20 Km per hour in the campus. Helmet bearing for two wheeler rider as well as pillion be made compulsory and triple riding on two wheelers should also be banned completely as per standing instructions issued by the University from time to time. The Security staff on duty at the University gates will also ensure that no student/employee/worker going on two wheeler will move in or out from the gates without helmet.

All the Statutory Officers/Heads of the Departments/Offices/Units are requested to bring the above to the notice of all employees / students /workers working /studying under their control for strict compliance.
