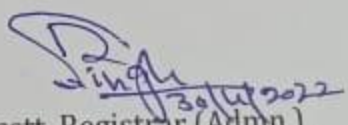
CIRCULAR

In order to maintain security and safety of the University employees, students, other workers and residents and to put a check on entry of unscrupulous elements to the campus, the Hon'ble Vice-Chancellor has been pleased to order as under:-

- 1) The entry to the main University campus and exit thereof with effect from **01.05.2022** will be through existing Gate No.3 only. The Security Personnel on duty at Gate No.3 will follow the procedure and instructions as have already been notified from time to time and applicable heretofore for Gate No.1. The Security Officer and the Security Supervisor will ensure scrupulous observance of the same.
- 2) With effect from **01.05.2022**, Gate No.1, except pedestrian/small gate, shall remain closed till further orders. However, it will be opened from **5.00 to 5.30 p.m.** on the working days **only for exit** of vehicles of University employees, project staff, students, outsourced workers and residents. No entry of any vehicle to the campus will be allowed through this gate.
- 3) All other gates of the main campus will remain closed. However, Gate No.5 will be opened from **5.00 to 5.30 p.m.** on the working days **only for exit of vehicles** of University employees, project staff, students, outsourced workers and residents. No entry of any vehicle to the campus will be allowed through this gate.
- 4) Pedestrians may enter or exit through the pedestrian/side gates at Gate No.1 and 5. Entry to Campus through these pedestrian/side gates shall be allowed only to those employees, project staff, Students, outsource workers and residents **who have Identity Cards** issued by the prescribed authority as already decided and notified. Accompanying person, if any, who does not have identity card will not be allowed entry through these pedestrian/side gates. The Security Personnel on duty will ensure compliance of these instructions meticulously.
- 5) The entry and exit to the University employees, project staff, Students, outsource workers and residents **who do not have Identity Cards** and to other visitors shall be allowed only through Gate No.3.
- 6) The Dean, Dr.G.C.Negi CoVAS will also devise a workable procedure for Holta campus immediately in consultation with the Security Officer/ Security Supervisor of the University and with the approval of competent authority.

All the Statutory Officers/Heads of the Departments/Offices/Units/ all Associate Directors/Scientists Incharge/Programme Coordinators are requested to bring the above instructions to the notice of all employees, project staff, students and outsourced workers working /studying under their control for strict compliance.
