NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 14th September, 2022 (Wednesday) as a "Public Holiday" (in case poll is held) only to the voters of Gram Panchayat Sainj, Development Block Theog, District Shimla on account of general election to above Panchayati Raj Institution.

All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments under Industrial Disputes Act and shops will remain closed on the said date in the areas of above Gram Panchyat (where elections are scheduled to be held). This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

Further, it is clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in the concerned Gram Panchayat (where general elections of PRI are scheduled to be held) on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.


