

Subject:- Regarding releasing the payment of Pension, Leave Salary & DCRG contribution.

Sir,
Kindly refer to CSKHPKV Registrar's office letter No 2-19/CSKHPKV/RSS/AKT/-225-228 dated 14-10-2020, 12-01-2021, 02-06-2021, 19-06-2021, 27-09-2021 & 20-01-2022, CSKHPKV palampur Registrar's office letter No. QSD.1-9/2018-Vetting/CSKHPKV/Pension/-60679-80 dated 08-09-2021 & QSD.9-1391/2k/CSKHPKV(Estt.II)/47845-847 dated 06-07-2022 and Dr. Y.S. Parmar UHF Nauni Registrar's Office letter No. UHF. Regr.Estt.II/8-1116/2008-47090-93 dated 19-03-2021 & UHF/compt./Estt/PF/KF/2021/1630 dated 17-06-2021 & UHF.Regr.Estt.II/8-1116/2008-35876-79 dated 04-01-2022 on the subject cited above.

In this context, it is submitted that the matter has been examined and it is observed that pension/CPS contribution & leave contribution in r/o employees deployed on secondment basis are not being made on time despite many reminders. Besides, from perusal of above communications of the lending organizations, it has been observed that calculations for leave & pension/CPS contributions are not being made as per terms & conditions of secondment as conveyed at the time of secondment arrangement. The points observed in deviation to the terms & conditions are as under:-

1. Calculations for leave & pension/CPS contribution are being made on maximum of Pay band + Grade pay instead of Basic pay + G.P. as per FR 116 read with appendix 2.
2. Pension/CPS contribution is calculated at 11% instead of 10%.
3. Contribution towards DCRG is claimed whereas there's no mention for the same in the terms & conditions.

Hence, you are directed to make payment on a/c of Pension /Leave contribution to the concerned lending institutions as per terms & conditions within a period of one month under intimation to this office (copy attached). In case of any disagreement, may take up the matter with the lending institutions.


