**OFFICE ORDER**

**17 FEB 2023**

In pursuance of Himachal Pradesh Government policy with regard to regularization of Daily Waged/Contingent Paid workers as circulated by the Department of Personnel vide letter No.PER(AP)-C-B(2)-1/2014V.-II dated 28.03.2022 and further adopted in the University vide notification No.QSD.4-8/2017-CSKHPKV(GA)Vol.IV/-61665-764 dated 07.09.2022 and on the recommendations of the duly constituted Screening/Selection Committee, the following Daily Waged Workers/Contingent Paid Workers who have completed 04 (four) years of continuous service (with minimum of 240 days in a calendar year, except where specified otherwise for the tribal areas) as on 31.3.2022/30.9.2022, are hereby regularized **provisionally** from prospective effect to the temporary post(s) of **Beldar**, created vide notification No.QSD. Bud.1-3/CSKHPKV/43173-272 dated 30.8.2018 on supernumerary basis, in the Level-1 of pay matrix of HPCS (Revised Pay) Rules, 2022 plus allowances thereon as sanctioned by the Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya, Palampur from time to time from the date they report for duty to the Head of Departments/Units/Offices as shown against each:-

The regularization is subject to the following conditions:-

- i) That they will have to produce medical fitness certificate from the Medical Officer, CSKHPKV, Palampur or the H.P. State Govt. at the time of their joining;
- ii) That they will be on probation for a period of two years in the first instance;
- iii) That they will be governed under the University Contributory Pension Rules,2007 (Now NPS);
- iv) That they will be liable to be posted anywhere within the territorial jurisdiction of the Vishvavidyalaya;
- v) That they will have to perform the duties as assigned to them by the concerned HOD/Controlling Officer.
- vi) That their regularization is subject to verification of their character and antecedents. The officials concerned will submit duly filled and the signed attestation form and self-declaration form as circulated vide Notification No.QSD.2-9/2016-CSKHPKV(GA)Vol.-XI/-37187-287 dated 29.7.2020, at the time of their joining. It is made clear that the regularization shall be provisional till verification of character & antecedent and in case character & antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self-declaration, the provisional regularization order will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence.

**The exercise of the verification of character & antecedents should be carried out by the concerned Head of Department immediately and the report received from the verifying authority shall be sent so as to reach in this office within 6 months of the issue of this regularization order.**

- viii) That their seniority will be determined according to the rules of the Vishwavidyalaya/instructions contained in the policy ibid;
- ix) That they will be member of Group Saving Linked Insurance Scheme of Life Insurance Corporation of India or if the said scheme has been withdrawn/discontinued by the LIC of India, any other Group Insurance Scheme as may be adopted by the University as per the requirement of the Statute;
- x) **That since the post(s) against which they have been regularized, are on supernumerary basis, the post(s) shall be deemed to have been abolished on superannuation/ retirement/vacation by them;**
- xi) That claim of belonging to reserved category will be subject to verification of certificate by the University from the issuing authority. **The exercise of the verification of certificate of reserved category should be carried out by the concerned Head of Department immediately and the report received from the verifying authority shall be sent so as to reach in this office within 6 months of the issue of this regularization order.**
- xii) that they will have to submit a return of assets and liabilities on joining;
- xiii) That no TA/DA will be paid to them for joining the post;
- xiv) That your appointment to above post is provisional and is subject to the further orders of Hon'ble High Court passed in CMP No.3418/2021 in CWP No.1866/2021 titled as Prem Singh Draik and Ors Vs. Union of India & others as per instructions contained in letter No.PER(AP)-C-E(3)-2/2021-Vol.-III dated 10.11.2021 from the Department of Personnel, HP Govt. read with letter No.Agr.A-B(15)-1/2021 dated 20.11.2021 from the Secretary (Agr.) to the Govt. of HP.
