The Vice-Chancellor has viewed it seriously and ordered that henceforth the Statutory Officers/ Heads of Departments/Offices/Units will arrange to evacuate the animals from the area/vicinity of their College/Organization/Offices/Hostels etc. to outside the campus through their category "D" staff/security person(s) posted under their control. The Estate Officer, CSK HPKV, Palampur will also arrange to take such action in respect of the residential colonies areas. The Vice-Chancellor has also desired that the stray/abandoned animal should not appear/seen in the area/vicinity of any College/ Organization/ Office/ Hostel etc. in any case.

All the Statutory Officers/Heads of Departments/Offices are requested to ensure strict compliance of the above orders in letter and spirit.
