**Subject: Issuance of Identity cards.**


Sir/ Madam,

I am directed to invite your attention to letter No. QSD 8-32/2020/CSKHPKV(GA)/-62652-751 dated: 24.03.2022 vide which it was directed to ensure issuance of Identity Cards/ Vehicle entry gate passes to all the employees/Students working/studying in the University and to report **compliance by 25.03.2022**. The compliance as above has not so far been reported to the Hon'ble Vice-Chancellor who has viewed it seriously and has ordered that the identity cards to the teachers/scientists, employees, project staff, students and campus residents be ensured to be issued by **03.05.2022 positively** failing which the officer authorised for issuing the Identity cards/ Vehicle entry gate passes shall be held personally responsible and any consequences caused for want of these documents while enforcing the instructions issued vide circular No. QSD 8-73/2022/CSKHPKV((GA)/-32273-392 dated: 30.04.2022 shall also be taken as the personal responsibility of the concerned officer. **The Hon'ble Vice-Chancellor has further ordered to ensure that all the teachers/scientists, employees, project staff, students and outsource workers should come to duty from 04.05.2022 onwards wearing the Identity cards failing which it will attract suitable action against the HoD/ Controlling Officer of the defaulter.**

You are, therefore, requested to take necessary action in the matter accordingly and report complete compliance on **04.05.2022 without fail**.
