**NOTIFICATION**

Subject: **Rates of Green Tea Leaf (GTL)**

It is notified for all concerned that the Director of Research of the University, *vide* his office communication No. QSD/1-5/DR-CSKHPKV(Acctts)/21/-9136 dated 09/02/22, has been pleased to approve rates for sale of **Green Tea Leaf (GTL)** of the Department of Tea Husbandry & Technology, CSK HPKV, Palampur as under:

1. If GTL is supplied to ‘Cooperative Tea Factories’: As per the rates fixed by the concerned ‘Cooperative Tea Factory’ from time-to-time.

**2. If GTL is supplied to ‘private parties’: Flat rates will apply as below with the following Terms & Conditions:**

Season/Period of the Year	Rate per Kg (Rs)	
	Plucked leaf supply	To be plucked by the party of its own
March/April - June	23	3
July - October/November	21	2

**Terms & Conditions:**

- i. The surplus certified organic green tea leaf (GTL) of the department will be available for supply/sale on ‘first come - first serve’ basis to be lifted by the buying agency from the concerned tea garden of the department..
- ii. The interested parties may submit their willingness to the Head, Department of Tea Husbandry & Technology, CSK HPKV, Palampur 176 062, HP to this effect. In the event of there being more than one interested parties, the party offering higher rate(s) than the approved ones will be given preference. However, decision of the Head of the Department will be final & binding.
- iii. In case of “GTL to be plucked by the Outside Party of its own”, the approved party will follow standard / rationale plucking practices and shall be responsible to maintain the plucking table & plucking rounds without causing any damage to the tea bushes.
- iv. Plucking/Grading/Weighing, etc. (whichever the case may be) will be done in the presence of a designated official or committee of the department & a designated official of the buying agency.
- v. The payment has to be made every week (on Monday/Tuesday) by the buying party for the bought GTL of the previous week.
- vi. In case of any legal dispute, the matter will be settled in the jurisdiction of Court of Law, Palampur (HP).
- vii. Lifting of GTL from the departmental tea farm will be the responsibility of the buying firm. The firm will adhere to the provisions of Motor Vehicle Act for transportation of material.
- viii. The buying Firm will have to deposit a refundable/adjustable security amount of Rs 50,000/- as an advance with the Head of the Department.
- ix. The security money will stand forfeited in the event of failure to lift the “plucked GTL” or default on account of non-payment for GTL on-time or non-compliance of any of these ‘Terms & Conditions’ by the party.
- x. The buying party will give an undertaking that it “Agrees to these Terms & Conditions”.
