OFFICE ORDER

Any act which violates the dignity of the individual student or is perceived to violate his/her dignity falls under the definition of ragging. Further, the act of seniors which violates the personal dignity of juniors and causes him/her undue mental or physical harassment by way of causing or forcing a student to do any act which detracts from human dignity or expose him/her to ridicule or forebear from doing any lawful act by intimidating, restraining, confining or injuring him/her by using criminal force which can lead to mental torture or death.

Therefore, anti-ragging committees of faculty of DGCN COVAS have been constituted and notified vide this office order No.QSD/ DCOVAS/ VIII-9(i)/Acad/- 3850-3920 dated 17.07.2018 to keep vigil and check the evil of ragging in and around the College Campus. Further, to monitor the work of anti-ragging committees and also to curb the menace of ragging, the following committee is hereby constituted which shall monitor the work of anti-ragging committee and hold meeting with the concerned faculty members from time to time and to ensure that the anti-ragging committees constituted for the purpose shall start its functioning right from the very outset of the Academic Session i.e. 25th July, 2018 and further perform their duties regularly on the dates specified in the above said notification. The committee will meet weekly and work out the modus operandi to curb ragging and will submit its report to the undersigned.
