4. The admissions through 2nd Walk-in-Interview will be made as per provisions contained in Information Brochure & Prospectus Merit Based Admissions 2018-19 for B.Sc. Physical Sciences(Physics, Chemistry & Mathematics), B.Sc. Life Sciences (Botany, Zoology & Chemistry), B.Sc.(Hons.) Community Science, B.Tech.(Food Technology), B.Sc.(Hospitality & Hotel Administration) & Doctoral Programmes.
5. The candidates who had applied earlier for the above degree programmes need not apply again but have to appear for 2nd Walk-in-Interview on the specified date by 11.00 AM. If any such candidate has not applied earlier under SFS category, he/she can apply for the same by depositing the requisite fee on the spot before 11.00 AM on the day of 2nd Walk-in-Interview. Further, if a candidate who had not earlier mentioned his/her category or failed to produce the desired certificate, he/she can also apply under the said category by producing the respective certificate.
6. All eligible candidates who did not apply for admission earlier can do so by applying with requisite fee on the spot latest by 11.00 AM on the day of 2nd Walk-in-Interview for the respective programme.
7. The candidates shall have to bring all the original certificates/testimonials and other documents relating to admission with one set thereof duly self attested for admission through 2nd Walk-in-Interview.
8. The admission shall be made on the basis of merit list (as per mode of admission) to be drawn on the day of 2nd Walk-in-Interview.
9. The candidates appearing in 2nd Walk-in-Interview must have to bring a demand draft of requisite amount of fee except hostel charges drawn in favour of the Comptroller, CSKHPKV, Palampur and deposit the same on the spot in case they are offered a seat for admission.
10. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
