**NOTICE**

It is for the information of all fresh candidates placed in Select List/Waiting List for admissions to Undergraduate, Masters' and Doctoral programmes of CSK H.P. Krishi Vishva vidyalaya, Palampur for the Academic Year 2020-21 that keeping in view of the COVID 19 pandemic, the University has also taken the following decisions:

1. The candidates selected/placed in the waiting list can also register for admission to the programme(s) provisionally without medical fitness certificate but such candidates shall have to submit/ produce medical fitness certificate from any Govt. Hospital on the prescribed format within 15 days after the date of registration.
2. The candidates who are CORONA positive during the period of registration/admission to the programme, can deposit the requisite fee in the Comptroller's Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction on or before the date of registration and send proof thereof alongwith authentic proof of suffering from CORONA positive from ICMR COVID-19 test facility to the concerned Dean through email on the day of registration upto 4.00 PM so that the seat for admission to the programme can be reserved for him/her provisionally but such candidates should have to report physically for verification of his/her original certificates/documents relating to admission to the concerned Dean immediately after he/she is declared negative from COVID 19 pandemic and get himself/herself registered for admission to the programme as per mode of admission/registration.
3. The candidates who intends to stay in the hostel, shall have to apply to the Students' Welfare Officer, CSKHPKV, Palampur for accommodation in the hostel and on allotment of accommodation, they shall have to deposit Rs. 5000/- (Rupees five thousand only) as mess security directly in the Students' Welfare Officer Account No.10640344201 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and submit the computer generated receipt or bank receipt as a proof of deposit of fee in the office of the Students' Welfare Officer so that accommodation in the hostel can be reserved. However, such candidates should also have to submit the negative test report COVID 19 from ICMR COVID-19 test facility to the Students' Welfare Officer, CSKHPKV, Palampur at the time of occupying the accommodation in the hostel and the said test report of COVID 19 should not be more than 5 days old.
