IMPORTANT INSTRUCTIONS TO THE CANDIDATE

1. The NRI candidate is advised to report in person to the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur for registration during the days of registration w.e.f. 26.07.2017 to 29.07.2017 from 10.00 AM to 5.00 PM and get himself registered as per Mode of Registration described in the Information Brochure & Prospectus Entrance Test Based Admissions 2017-18.
2. The NRI candidate shall have to pay requisite fee on or before 29.07.2017 in the form of demand draft in US \$ issued against the bank account of NRI in the country in which he is residing or in the shape of demand draft in equivalent Indian currency issued against his NRI account, maintained in India. In the latter case, he is required to submit a certificate from the bank that the draft has been issued against his parents'/guardian's NRI account. The demand draft should be drawn in favour of the Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled bank at Palampur, India.
3. If the NRI candidate fails to register himself as per Mode of Registration and pay the fee by the due date of registration, his candidature will be cancelled.
4. If the candidate fails to deposit the prescribed fee on or before 29.07.2017 upto 5.00 PM and gets himself registered in person during the days of registration w.e.f. 26.07.2017 to 29.07.2017 upto 5.00 PM, his candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.
5. The NRI candidate shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure VI as per medical and physical fitness standards prescribed in Annexure VII of the Information Brochure & Prospectus at the time of registration.
6. At the time of admission, student shall be required to fill online Anti Ragging Undertaking (Affidavit) at www.amanmovement.org.
