Applications, complete in all respects, should reach in the office of the Dean, College of Home Science, Palampur-176062 (HP) latest by **22.7.2017 upto 5.00 PM**. **Essential Qualifications:-**

M.Sc. / M.Tech. having qualified National Eligibility Test (NET) from ICAR, CSIR-UGC or similar test accredited by UGC/State in the concerned discipline.

**Note:-**

- i.) For the candidates having Master's Degree, NET shall remain compulsory alongwith one publication in NAAS (National Academy of Agricultural Sciences, New Delhi) rated journal in the discipline in which NET is conducted. Essentiality of NET can be waived off for the candidates holding Ph.D. degree, provided it has been done with course work as prescribed by the UGC Regulations-2009 and the candidate has at least two full length publications having NAAS rating not less than 4, on the last date of submission of application. The candidates with Ph.D. degree without course work will not be eligible for this exemption.
- ii.) The condition of NET can be relaxed in exceptional cases by the competent authority.
- iii.) Retired university/College teacher(s) of the concerned discipline can also apply.
- iv.) Those who have already applied in response to earlier circular No.QSD/COHS/2015/CSKHPKV (Estt.)/-3548-97 dated 24.6.2017 need not to apply again.

- i) **For upto two practical batches:** Theory=2contact hour, Practical=1 contact hour, Total 2+1=3 contact hours.
- ii) **For more than two practical batches:** Theory=2 contact hours, Practical=2 contact hours, Total=2+2=4 contact hours.

8. The College/University reserves the right not to engage the hired person(s) in any of the above discipline(s).
9. No separate written/personal interview will be held for hiring the person(s) in the above discipline(s).

The incumbent can be assigned the duty to conduct examinations, perform invigilation duty, set up question paper(s), evaluate answer books alongwith submission of results thereof and counseling the students etc. whenever required for which he/she will be paid separate remuneration of Rs. 5000/ per course per semester.
