- 4- The rate quoted should be strictly according to the specifications stated as above.

- 6- The undersigned reserves the right to accept or reject the quotations without assigning any reason.
- 7- The quotations shall be opened on **07.03.2022 at 11.00 A.M.** in which the bidders can present.
- 8- The payment will be made after satisfactory inspection report of the material to be conducted by the Inspection Committee so constituted for the purpose by the University and passing the bill from the audit.
- 9- There should be no condition of Advance payment.
- 10- The validity period of quotations should be for six months from the date of opening the quotations.
- 11- The quotation received after due date will not be accepted.
- 12- The quantity of material can be increased/decreased.
- 13- Before the final printing, the proof is required to be got checked from the undersigned.
