

If the total value of the purchase exceeds Rs.1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 2% of the estimated value of goods in the shape of F.D.R/DD duly pledged in the name of the Comptroller, CSKHPKV, Palampur. The earnest money if any, already deposited/lying in the office of the undersigned will not be considered for current quotation. **The quotation without EMD will not be considered.**
11. Performance security @ 5% of the whole amount of the total supply will be obtained from the successful bidder along with bill.
12. **The E-way bill is to be required along with actual bill.**
13. **The GST is applicable @ 5% in the CSKHPKV, Palampur against GST Concessional Certificate being a Research University.**
