Size of outdoor badminton courts: length 13.4m, width 6.1m and requirement of light is –minimum 1200 lux all over the court and there should no direct glare on eye. All the specifications should be as per Sports Authority of India.</li><li>3. Height of poles and light intensity should be well enough to conduct local level domestic matches without any difficulty in both the courts. <b>Court Figures Attached</b></li></ol>

**TERMS & CONDITIONS**

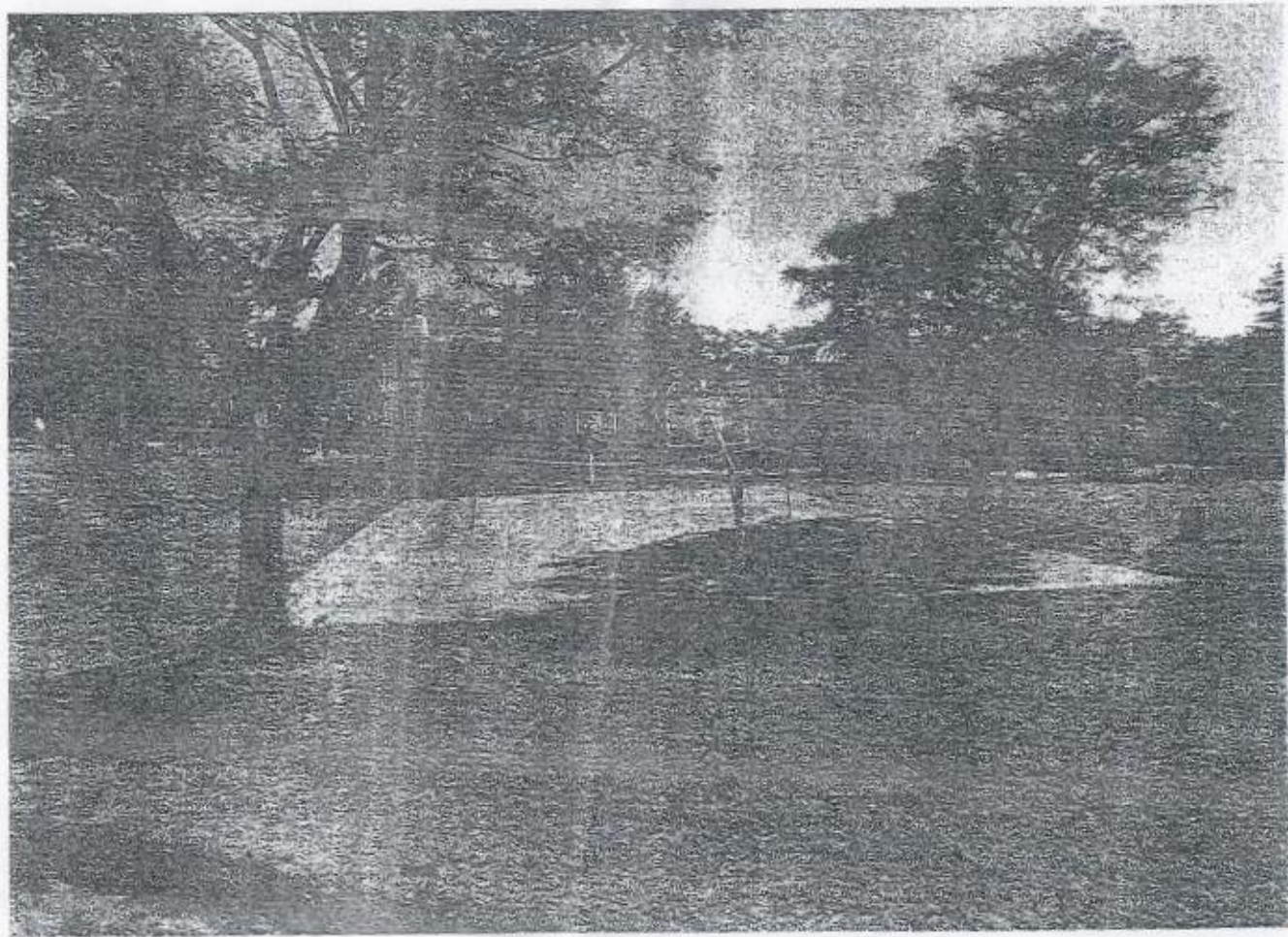
- 1) The quotation should be reach in the O/O the Comptroller, CSK HPKV, Palampur in sealed cover and super-scribed "quotation for purchase of Sports LED Lightings with complete installation with poles for both the courts" on 29-03-2022 by 5.00 PM. The quotation will be opened on 30-03-2022 at 11.00 AM in the presence of quotee or their authorized representative, if present.
- 2) The rates should be quoted F.O.R. CSK HPKV, Palampur inclusive of all charges. GST extra, if any. (Nothing will be paid extra).
- 3) Price list should be attached.
- 4) The quantity of materials can be increased or decreased.
- 5) The Comptroller also reserves the rights to consider or reject any of the quotations without assigning any reason.
- 6) The supply of the material is to be made by the supplier immediately.
- 7) The quotation received after due date will not be considered.
- 8) The condition of advance payment or through cash etc. will not be considered.
- 9) The quotation should be submitted only if the items can be supplied promptly on demand.
- 10) The price quoted should be strictly according to the specifications stated above.
- 11) The payment will be made after satisfactory Inspection Report of the Inspection Committee so constituted for the purpose by the University.
- 12) Each quotation should be accompanied with a refundable earnest money @ 2%, if the total amount for the supply of the material exceeds Rs. 1.00 lakh in the shape of fixed deposit receipts/TDR/DD in favour of the Comptroller, CSK HPKV, Palampur. **Without EMD the quotations will not be considered.**
- 13) The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
- 14) Performance security will be obtained from successful bidder @ 5% of the awarded material.
- 15) GST may be shown separately, copy of GST registration be enclosed with quotation and GST No. may be mentioned in the quotation.
- 16) The E-way bill is to be required alongwith actual bill.
- 17) Authorization Dealer Certificate and warranty certificate duly attested must be attached with quotation.
- 18) The quotation should accompany the satisfactory user report/certificate from the Institutions to whom the said work/ equipments earlier done/supplied by the firm.
- 19) The conditional quotation will not be entertained.
- 20) The firms/suppliers shall observe all the guidelines/SOPs for COVIDI-2019 prescribed by the H.P. State Govt/Central Govt. from time to time.

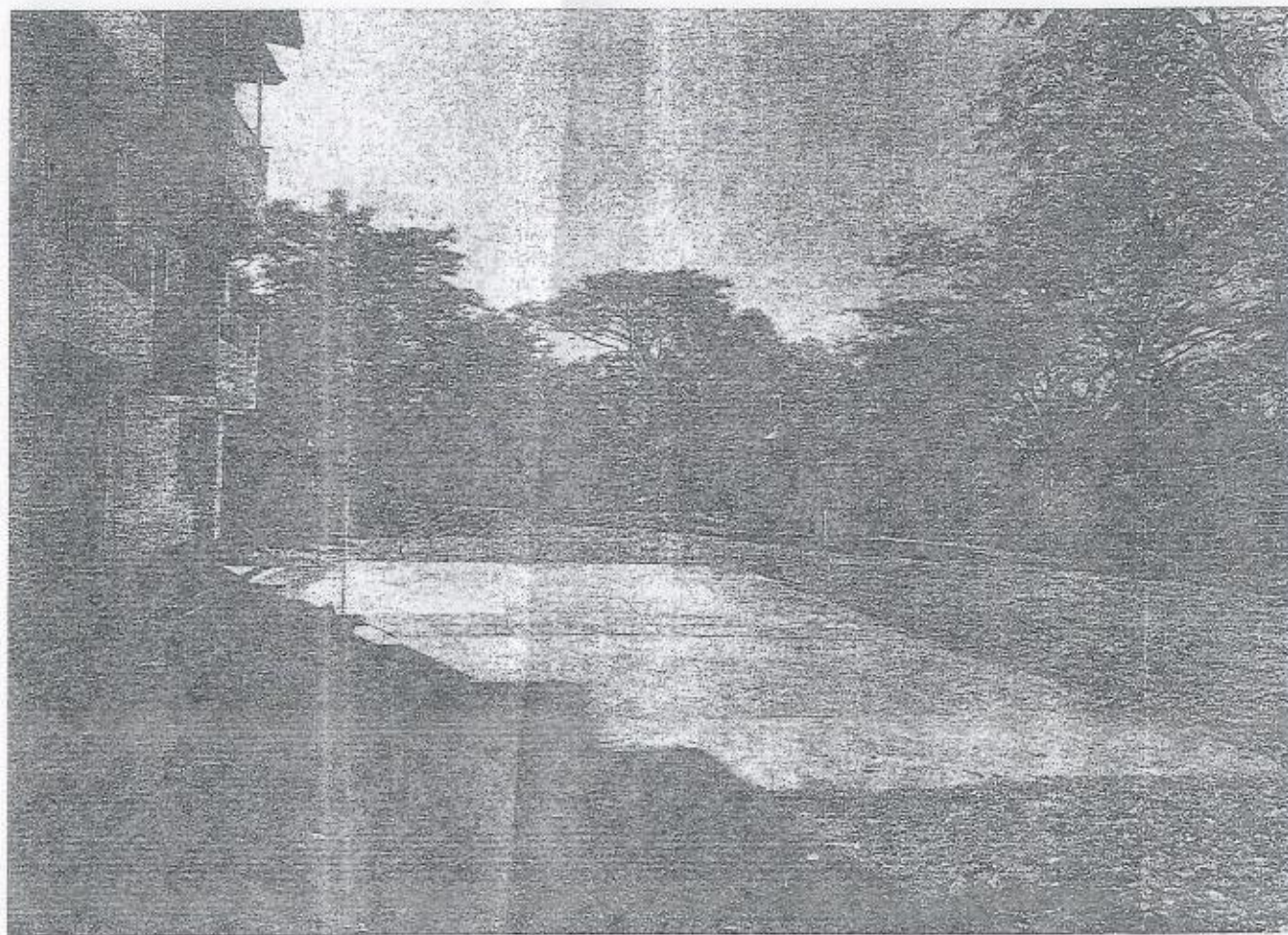

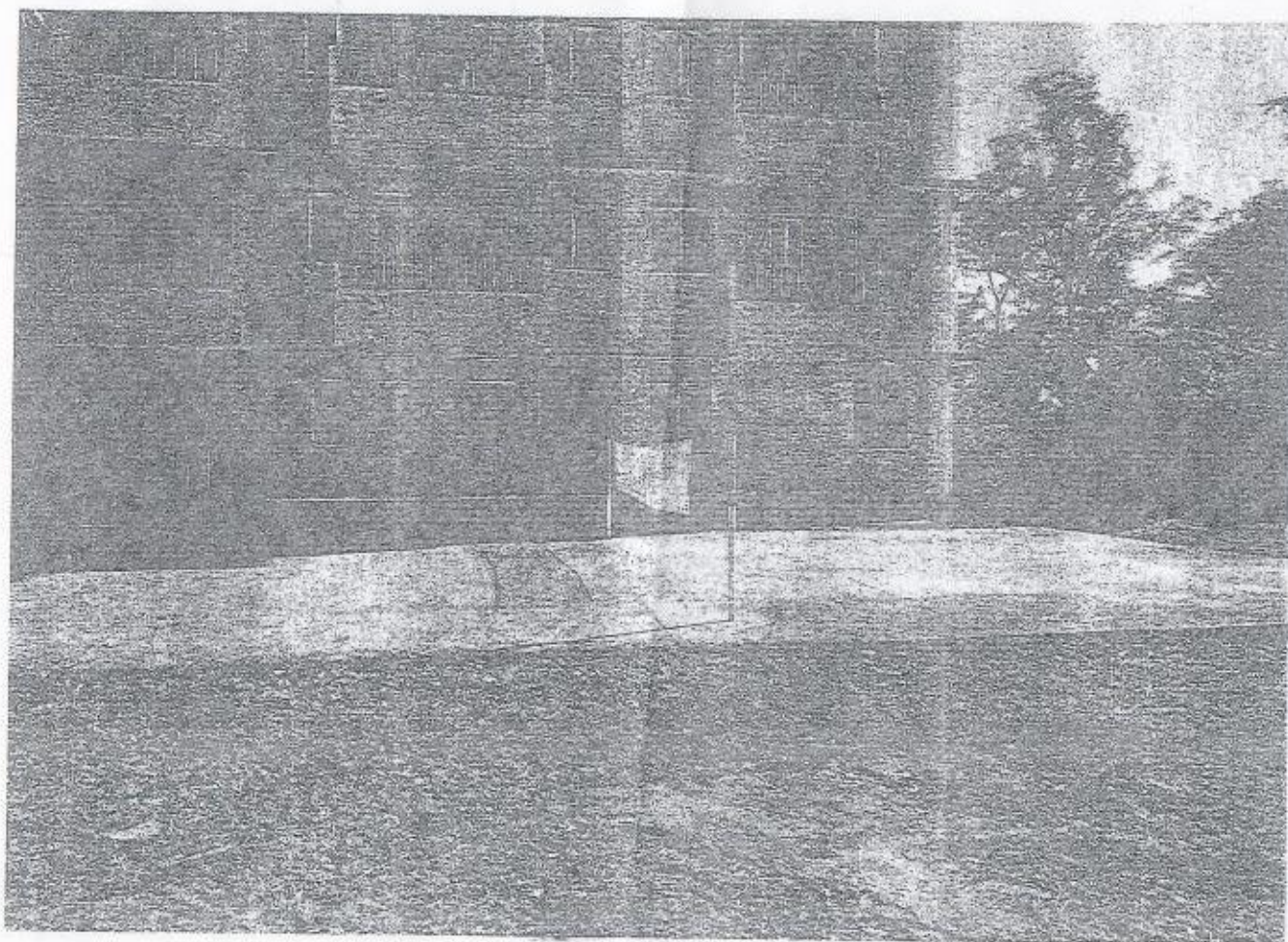
Basketball Court - Fig(I)
