The quotations will be opened on 19/04/2022 at 3:00 PM in the presence of quote or their authorized representative, if present. In case the date of opening is happened to be a holiday, the quotation will be opened on next working day on same time.
- 2) The rates should be quoted **F.O.R. destination i.e. Palampur** including of all charges. Nothing will be paid extra.
- 3) Concessional GST @ 5% will be applicable against GST exemption certificate issued by the University.
- 4) Price list should be attached.
- 5) The quantity of materials can be increased or decreased.
- 6) The University reserves the rights to consider or reject any of the quotations without assigning any reason.
- 7) The supply of the material is to be made by the supplier immediately.
- 8) The quotation received after due date will not be considered.
- 9) The condition of advance payment or through cash etc. will be considered.
- 10) The quotation should be submitted only if the items can be supplied promptly on demand.
- 11) The price quoted should be strictly accordingly to the specifications stated in the NIQ.
- 12) The payment will be made after satisfactorily Inspection Report of the Inspection Committee so constituted for the purpose by the University.

- 13) Each quotation should be accompanied with a refundable earnest money @ 2%, if the total amount for the supply of the material exceeds Rs.1.00 lakh in the shape of fixed deposit receipts/TDR/DD in favour of the Comptroller, CSKHPKV, Palampur. **Without EMD the quotations will not be considered.** Here, it may also **note that the Earnest money if any, already deposited / laying in the office of the undersigned will not be considered for current quotation.**
- 14) The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
- 15) Performance security @5% of the whole amount of the total supply will be obtained from the successful bidder before placing the supply order. The earnest money already deposited shall form part of performance security.
